 7. **Each senior nomination form shall be accompanied by a non-refundable fee of R25-00 including VAT.** Junior nomination forms do not incur charges.
 8. The completed Nomination Form shall be received by the Secretary, NDSAA, **NOT LATER** than the closing date as notified to all Clubs.
